

Background:

Broken seams located at secondary steering lines trailing edge attachment tapes have been reported on reserve canopy model Minimax 5 (Pn:203).

The assembly of steering lines attachment tapes to trailing edge of the concerned canopy is described by Figure A.

 - Pattern per Figure A as above: immediate grounding even if stitching or fabric are fully undamaged
 - Others stitching patterns: unless damaged, airworthiness is not affected
- 2- Record riggers marks on canopy documents, with "BS PdF N°2-2003, Airworthy" or "BS PdF N°2-2003, Grounded".
- 3- Report to PF S.A. using second page of present Safety Bulletin.

PF SA. will issue a Service Bulletin as soon as possible in order to state on measures to return to fly.
